In the event that action is required to enforce this agreement, I/We agree to pay all costs including late fees, shutoff fees, collection costs (including additional 35% collection fee), court costs and reasonable attorney's fees.

The terms and conditions contained within this agreement shall be governed by the laws of the State of Utah and shall be construed and interpreted in accordance with those laws. Any action or proceeding brought by either party which is based upon or derived from, or in any way related to this agreement, shall be brought in a court of competent jurisdiction within the state of Utah.
